**Description:** Perfume-free and dye-free light duty lotion hand cleanser for regular use to remove general dirt and grime.

**Usage:** Suitable for general industrial and food manufacturing/processing environments. Use at the end of each work period or more frequently if required, to remove everyday industrial and food related contaminants.

**Method of Use:** Apply 1 dose to dry hands. Rub in well and rinse thoroughly with clean running water. Wipe dry with disposable paper hand towels.
