5. <u>Fire fighting measures</u>	Not explosive. Not auto-flammable. Not flammable. The wipe lotion itself will not burn. If anything, packaging may be involved in a fire. Use CO ₂ , dry chemical powders or alcohol resistant foam. If water is used, contain run-off.
6. <u>Accidental release measures</u>	Avoid spillage into sewers or surface water. For large spills: pump into plastic containers and rework/dispose as per local legislation. For small spills: use non-combustible absorbant and shovel into container for disposal.
