### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

##### General information

Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

##### Inhalation

Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. #### **Appropriate engineering controls**
